

# NOTICE OF COORDINATED ELECTION KIOWA COUNTY, COLORADO

## Date of Election: November 7, 2017

## Mail Ballot Election

In accordance with the provisions of the Colorado Revised Statutes and the Colorado Constitution, notice is hereby given that a Coordinated Election will be held in the State of Colorado, County of Kiowa, on Tuesday, the 7th day of November, 2017. The election will be a mail ballot election. Ballots will be mailed to each active registered elector in accordance with C.R.S. Section 1-7.5-107(3) (a) (I). Ballots may be mailed back to the Kiowa County Clerk and Recorder, PO Box 37, Eads, CO 81036, or delivered to the County Clerk's Office at 1305 Goff St., Eads, CO, during regular office hours of 8:00 a.m. to 4:15 p.m., Monday through Friday, 8:00 a.m. to 12:00 p.m. the Saturday before the election (11/04/2017)), and from 7:00 a.m. to 7:00 p.m. on Election Day (all ballots must be received by 7:00 p.m. on Election Day). This office is also the location to apply for a mail-in ballot if you are going to be absent from home during the election or a replacement ballot, if needed.

Not all of the candidates and questions will appear on every ballot. The following is a complete listing of the entities with candidates or issues for Kiowa County, Colorado:

<b>Instructions to Voters:</b>	
1. Mark your ballot with blue or black ink. 2. If you make a mistake, either request a replacement ballot from your County Clerk and Recorder, or cross-out any errors and add a note making very clear the voting choice you intend to vote. 3. To vote for a named candidate, completely fill the oval to the left of your choice. To vote for a write-in candidate, completely fill the oval to the left of the words "Write-in" and legibly print at least the first and last names of an eligible write-in candidate in the write-in area to the right. Vote like this:	
WARNING: Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges, or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both.
